**Proof of Citizenship Requirement: PASSPORT**

**Deposit/Final Payment Policy:**

- \$425.00 per person due at time of booking to secure a cabin.
- Final Payment is due May 22, 2024

**Cancellation Penalties:**

- If cancellation occurs from booking date to 5/21/24, a \$25.00 per person penalty will be assessed.
- If cancellation occurs between 5/22/24 - 6/25/24, a \$1,125 per person penalty will be assessed.
- If cancellation occurs between 6/26/24 - 8/20/24, passengers in full penalty & no refund will be granted.
- In addition to the cancellation policies listed above, if additional payments have been made to Starr for the purpose of securing your airline reservation, these monies are non-refundable once received.
- Any name changes after the final payment is made will be assessed as a per person change fee. The amount of the fee will be determined by the airline/cruise line.
