Proof of Citizenship Requirement: PASSPORT**Deposit/Final Payment Policy:**

- \$300.00 per person due at time of booking to secure a cabin.
- Final Payment is due April 28, 2024

Cancellation Penalties:

- If cancellation occurs from booking date to 4/28/24, a \$25.00 per person penalty will be assessed.
- If cancellation occurs between 4/29/24 and 6/2/24, a \$300.00 per person penalty will be assessed.
- If cancellation occurs between 6/3/24 and 7/28/24, the passenger is in full penalty and no refund will be granted.
- In addition to the cancellation policies listed above, if additional payments have been made to Starr for the purpose of securing your airline reservation, these monies are non-refundable once received.
- Any name changes after final payment are made will be assessed as a per person change fee. The amount of the fee will be determined by the cruise line.
