Deposit/Final Payment Policy:

- \$425. per person due at time of booking to secure a cabin.
- Final Payment is due July 5, 2024

Cancellation Penalties:

- If cancellation occurs from booking date to 7/5/24, a \$25.00 per person penalty will be assessed
- If cancellation occurs between 7/6/24 and 8/9/24, a \$300.00 per person penalty will be assessed
- If cancellation occurs between 8/10/24 and 10/4/24, the passenger is in full penalty and no refund will be granted.
- In addition to the cancellation policies listed above, if additional payments have been made to Starr for the purpose of securing your airline reservation, these monies are non-refundable once received.
- Any name changes after final payment is made, will be assessed a per person change fee. The amount of the fee will be determined by the cruise line.
