**Proof of Citizenship Requirement: PASSPORT****Cancellation Penalties:**

- If cancellation occurs from booking date to 4/22/24 a \$25.00 per person penalty will be assessed
- If cancellation occurs between 4/23/24 and 6/5/24, a \$1,600.00 per person penalty will be assessed
- If cancellation occurs between 6/6/24 and 8/24/24, the passenger is in full penalty and no refund will be granted.
